The online Open Forum on HB228 had over 50 participants. The participants decided not to record the meeting or create a transcript. Instead, some notes were taken to be posted later.

Most of the faculty in attendance are not members of the AAUP, and this was not an official AAUP meeting. Several faculty members in attendance decided to join the AAUP, so there will be a meeting to elect new officers in about a month when they have had a chance to join on the national website.
